By signing this agreement, you agree to the following terms & conditions:

<u>COMMITMENT</u> - You commit to a minimum of a 6 consecutive month membership term. Monthly membership fees are charged automatically each month to your debit or credit card. If for any reason your membership lapses for one or more months, a new 6 month commitment will be in effect when you resume your membership. Once you have satisfied your 6 month minimum commitment, your membership will continue month to month, until you cancel it.

<u>NON-TRANSFERABLE</u> - Member will receive the benefits listed above. Benefits are not transferable to anyone else and member benefits cannot be combined with any other offers, specials or discounts.

<u>SUBSTITUTIONS</u> - Each membership includes 1 prepaid massage per month, and additional unlimited massages of the same length can be purchased for the same price as the monthly rate. These benefits cannot be substituted, upgraded or broken into shorter sessions. Shorter, longer, different services can be purchased using the 10% discount benefit.

<u>APPOINTMENT CANCELLATIONS</u> – All clients are required to give 24 hour notice for any cancellations or rescheduling. If the member provides less than 24 hours notice or no-shows for an appointment, that month's prepaid massage will be forfeited or the member will be charged in full for their appointment.

TERMINATION

- The membership may be terminated at anytime by either the member or The Massage Store for any reason.
- If a member wishes to cancel their membership, they must fill out The Massage Store's Membership Cancellation Request form (can be obtained in our store or on our website) and submit it to our office. Monthly membership fees are not pro-rated and will not be refunded. Any unused prepaid massages will be forfeited as of the membership end date.
- If the desired membership termination date is within 6 months of the member's sign up date, a cancellation fee equal to one monthly payment will be assessed.
- The member can terminate their membership contract (by filling out the Membership Cancellation Request form) within 3 days of signing the Membership Agreement without penalty. The membership fee will be refunded, but any benefits the member received must be reimbursed to The Massage Store at full retail value.

<u>CHANGES TO AGREEMENT</u> - Any changes in the terms and/or conditions of this agreement or the membership will be sent to the member a minimum of 30 days in advance to the member's e-mail address on file.
